We will gather in front of the East Front of the U.S. Capitol (side of Capitol facing the U.S. Supreme Court) for a group photo before breaking for our meetings.

PHCC will make all arrangements for you and your state delegates to meet with your Members of Congress. We will discuss the following issues:

- Tax Reform: The Tax Cuts and Jobs Act of 2017 reduced the federal corporate tax rate to 21%, allowed tax deductions for qualified business income and increased estate tax thresholds to minimize the tax burden on family businesses preparing to transition to the next generation. However, many of these tax policies are set to expire at the end of 2025 resulting in tax increases and uncertainty for American businesses. The new Congress and administration has made tax reform a top priority for this year which would extend key provisions and further reduce the corporate rate to 15%.
- Workforce Development and Funding: As we enter appropriations season, we must ensure continued funding for programs that provide pathways to careers in plumbing and HVAC, including the Department of Labor's registered apprenticeship program, Workforce Innovation and Opportunities Act (WIOA), and Perkins Career and Technical Education (Perkins CTE). We must also support workforce policies that continue to ensure apprenticeship programs produce journey workers with the holistic skillsets needed to succeed in construction trades.
- Consumer Impact on Electrification: As Congress and the Trump
 administration reconsider the Inflation Reduction Act (IRA), plumbing and
 HVAC contractors know better than anyone else the costs and realities of
 electrification policies on consumers, such as the ability to keep homes
 warm and water hot during the winter months. Lawmakers will want to know
 how the IRA has worked out for you and your customers, and whether rebate
 programs are worth continuing or modifying.
- Responsible Energy Policy: America's energy portfolio must remain diverse
 and leverage the energy resources we have right here at home. Fossil fuels
 such as natural gas must be part of the solution America can't do it on
 renewable energy alone. Robust energy legislation that includes the Energy
 Choice Act will ensure Americans continue to have affordable and efficient
 choices in how they power their homes and businesses.
